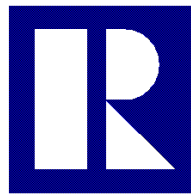

**COMMITTEE DUTIES**

**AWARDS, NOMINATING & ELECTION COMMITTEE**

This can include an additional award, the **Bruce R. Flanagan “Good Samaritan Award,”** to a member, affiliate member or staff employee. This award is to be presented when an eligible recipient is determined to be deserving of this award.

## CIVIC AFFAIRS, LEGISLATIVE & RPAC COMMITTEE

**PROFESSIONAL STANDARDS COMMITTEE**

This committee will conduct Ethics and Arbitration Hearings, as forwarded to the committee by the Grievance Committee, regarding alleged violations of the Code of Ethics of the National Association of REALTORS, and to settle business disputes involving members of the Association, as defined in Article 14 of the Code of Ethics. Members of the Committee shall be required to attend a course of instruction of Professional Standards, to be presented by the Association.
